- Developing a Shared Nature-based Solutions Definition | 1:30 1:50p
 - Attendee Talking Points
 - Importance of thinking about climate impacts, and NbS solutions as being resilient to changes we are seeing/will increasingly see (Edith de Guzman)
 - Important to think about disability considerations when planning NbS solutions. In most cases surfaces must comply with the <u>ASTM F 1951-99</u> standard for accessible surfaces (Charming Evelyn)
 - Ex. Artificial Turf is an ADA recommended surface
 - Need to develop & offer resources for hands-on education to the public (Samantha MJ Yang)
 - Lots of individuals interested in waterwise landscapes but lack of adequate access to resources stymies implementation at a personal level
 - Need to shift the focus to truly nature-based planning (Tim Brick)
 - Ex. restoring natural hydrology, restoring native biodiversity
 - Creating healthy ecosystems and promoting healthy biodiversity cannot be separate from human health considerations (Kelsey Jessup)
 - Very important to define what "keeping constraints in mind" means for this task force (Melanie Winter)
 - We can't stop with creating a definition of what NbS is. We have to build capacity to support the vision of this task force.
 - Import to define and write out what constraints are so we have a shared understanding and can challenge them (Kelsey Jessup)
 - "It's important to go in with the mindset that we are Nature. We are a part of Nature. We need clean water to survive, we need clean soil to provide healthy and nutrient and mineral rich foods. We have to keep in mind that the plants, animals, insects, Indigenous peoples to the area, land, rocks, water, ocean, all living beings must be included in the plan of protection, healing and expanding back into a more natural world." (Jessa Calderon)
 - Given that CBO/NGOs are *theoretically* on such parallel tracks w/ agencies charged with building, operating, & maintaining NbS projects, there is a need to create on-ramps for agencies to join in more with NbS efforts (Meredith McCarthy)
 - Any definition should include something maximizing or optimizing what we're getting at + avoiding a check-box solution (Craig Doberstein)
 - Prescriptive vs Descriptive
 - More conversation at the local level (code enforcement for example) may be helpful in moving projects forward (Claudia Arends)

- If this is a definition that is intended to cross multiple plans, it is important to make sure this definition is not restricting other agencies, organizations, etc. from using it to guide their planning (Maggie Gardner)
- Think about beach dune restoration for improving stormwater quality as it flows into the ocean (Melina Watts)
